- (13)Licensed Pharmacist and Primary Pharmaceutical Service
- (14)Clinical Pathway——The Effect and Practice of Pharmacists

- (16) The Practice of Clinical Pharmacist——Antitumor Therapy Cases

2. Requirments and formats for papers:

(1) Content

The contents of lately research papers, special reports and reviews within 16 categories above.

(2) Usage

A: All the authors of chosen papers have opportunities to make an oral or poster presentation during the forum and qualify for complimentary registration. One paper offers one complimentary registration;

B: The excellent papers passed the review of committee of experts will be

recommended to full-length publish on Drug Evaluation;

- C: The participants will be accredited with 6 points of National I class continuing education credits;
- D: The submitted papers will be the precious communicating and sharing materials.

(3) Requirements for papers

A: Requirements for academic papers:

- **a:** The maximum length of the paper is 5000 words(including charts), including 500 to 800 words of abstract. The abstract should includes 4 parts: ①purpose; ②method; ③result; ④conclusion;
- **b:** Each participant limits to submit within 3 papers as first author. Each paper should includes the authors' name, company/institute, address, zip/postal cade, telephone or E-mail;
- **c:** The paper and abstract should be saved as Word document and A4 setting. PDF, graphics or other forms will not be accepted;
- **d:** Editors will only edit font, size, and format and will not edit the content of paper. The author is taken responsibility of its contents.
 - **e:** The papers do not meet the standards above will not be accepted;

B: Requirements for clinical pharmacist practical cases:

Clinical pharmacist practical cases should include 4 parts: 1 case introduction; 2 the major progress of diagnose and treatment; 3 discussion; 4 reference.

- **a: Case introduction:** Mainly Past Medical History, history of present illness, Medication history, laboratory report, imaging tests involving in discussion, not all detail description of diseases.
- **b:** The major progress of diagnose and treatment: According the time clues, objectively and concisely introduce the treatment and important change of disease state. The speaker can explain the choice of treatment strategies without

personal comment.

c: Discussion: According to the whole picture of treatment and focused on 1 to 2 important "points", speakers should cite classical and authoritative materials to illustrate these "points" so that to broaden audiences' horizon. It is vital that a specialized pharmacists can analysis a specific content in wide and depth.

d: Reference: The authors should mark the reference in order,

e: The articles do not meet the standards above will not be accepted;

(4) Important date

A: The deadline to submit papers is: 1 March 2014

B: The results of review will be published on: 31 March 2014

(5) The way to submit:

a: Every paper should be submitted to E-mail: fcpf2014@cjpif.org

b:The form of the E-mail theme should follow this format: "practical cases(papers)-theme-name"

c: Please submit practical cases(papers) with "Appendix 1: The Application Form of 2014 Forbidden City International Pharmacist Forum" together.

d: The committee will reply E-mail after receiving it.
