## **FACTS ABOUT DUSSELDORF**

- **1. Kö** is the common short name for "Königsallee". It's the central boulevard in Düsseldorf. The eastern part of the street is said to be the one to be on if you want to go shopping on a quite luxury scale. It's the Champs-Élysées or Sloane Street of Nordrhein-Westfalen. Recently, brands of a more affordable price segment settled down here, such as H&M, Zara and Esprit. Shop opening hours in Düsseldorf (Center) Monday to Friday: 10.00 -20.00 hrs Saturday: 10.00 20.00 hrs
- 2. Alt is actually German and means "old". But it's also just another term for "Altbier". It's your Düsseldorf sort of top-fermenting beer. You can try one in one of the brewery-pubs like Füchschen, Schumacher, Schlüssel, Uerige and Kürzer. In the shops you will get the most successful brand "Diebels" (they also have other sorts of beer), other popular names are Frankenheim, Schlösser Gatz, Hannen and Rhenania. With its 260 cosy pubs and home-brew taverns Dusseldorf is well known as "the longest bar in the world".
- **3. Fashion** plays a BIG role in Düsseldorf. No other German city is as successful in this branch of trade. Düsseldorf hosts one of the biggest fashion fairs in Europe, the "Collections Premieren Düsseldorf". More than 600 showrooms are located in the capital of NRW.
- **4. Düsseldorf** is the capital of the German state of Nordrhein-Westfalen (NRW). Just under 600,000 people live there, making it Germany's 7th biggest city just behind Frankfurt and Stuttgart. It is a major industrial, financial, and commercial center; a busy inland port; and an important rail junction. It has three harbors on the Rhine and one of the nation's busiest civil airfields at Lohausen.

## **FIP Ethics Focus Group**

An Ethics Focus Group has been established by FIP and is co-chaired by Mr William Zellmer (USA) and Dr Betty Chaar (Australia). The intent of the group is to build upon the foundation established by the FIP Statement on Codes of Ethics for Pharmacists\* and the FIP Reference Document, "Pharmacist Ethics and Professional Autonomy: Imperatives for Keeping Pharmacy Aligned with the Public Interest,"\*\* which was developed by the FIP Working Group on Pharmacist and Ethics and Professional Autonomy.

The proposed objectives of the FIP Ethics Focus Group are as follows:

- 1. To serve as an international discussion forum for pharmacists, pharmaceutical scientists, pharmacy educators, and others (including pharmaceutical organizations) on contemporary issues related to ethics and professional autonomy in pharmacy.
- 2. To establish an international network of pharmacists who wish to engage in reflection, analysis, and authorship of articles addressing ethical issues pertinent to the practice of pharmacy across the globe.
- 3. To emphasise and promote within pharmacy that whilst knowledge, science, and technology are the basis of expertise and provision of healthcare services, a profession cannot exist without a strong foundation of ethical considerations and recognition of its social responsibility to serve individuals and communities with the highest integrity and professional ethics.
- 4. To establish principles of teaching professional ethics in pharmacy in curricula around the world.
- 5. To encourage and engage in research about ethics in pharmacy.

- 6. To advise FIP leaders on initiatives and educational programming they should consider related to ethics and professional autonomy in pharmacy.
- 7. To offer assistance to FIP leaders in developing guidelines, codes, and responses to enquiries related to ethics and professional autonomy in pharmacy.

The questions we would like to discuss at our first meeting on 2<sup>nd</sup> Oct 2015, 10.30 a.m, Room 11, at the FIP Congress in Dusseldorf, are the following:

## **Discussion Questions:**

- 1. With respect to the draft objectives for the Ethics Focus Group, are there any parts that should be removed, added, or modified?
- 2. What are your ideas about how to pursue each objective?
- 3. Is there interest in creating an Internet-based mechanism for interested persons to regularly share information, questions, or perspectives related to ethics and professional autonomy in pharmacy? If so, is there volunteer capacity within the Focus Group to moderate and otherwise sustain such an effort?
- 4. What are the major facets of pharmacy ethics that should be given attention, in the near term, by the FIP Ethics Focus Group? How can these issues be identified (e.g. utilising open surveys; by having a dedicated blog; etc)?
- 5. What programs or activities related to ethics and professional autonomy in pharmacy should be considered for future FIP Congresses?

These questions are open for discussion at the meeting, and into the near future, as we build our core objectives and formulate a pathway for the Focus Group moving forward with clarity of identity and purpose. Please feel free to disseminate these objectives and discussion points to any colleague interested, and invite them to join us at the inaugural meeting.

We look forward to meeting those interested.
